They are currently in the liquidation process, which is expected to be completed within 2025. Upon the completion of the liquidation process, the shareholders of C9 Holding (Shareholders No. 4 and 5), Organics Holding (Shareholders No. 6 to 8), and Organics Asset Holding Corp (Shareholders No. 6 to 8) will become direct shareholders of the Company in proportion to their shareholdings. Once the rights to purchase ordinary shares under the 24CS-W1 and 24CS-W2 warrants are exercised, the shareholding proportions of 1. Ms. Pattmavadee and 2. the shareholders of C9 Holding (Shareholders No. 4 and 5), Organics Holding (Shareholders No. 6 to 8), and Organics Asset Holding Corp (Shareholders No. 6 to 8) will be as follows (assuming all existing shareholders fully exercise their rights under the warrants):
