- On 4 November 2025, Mr. Krasaung Charusira acquired the Company’s ordinary shares through the Stock Exchange of Thailand, via a securities company, by means of direct transactions with Mr. Akkarapong Prasiyoosin and Mr. Thanawat Tangwatthanaphunphon. As of 4 November 2025, Mr. Krasaung Charusira held 12.2989 percent of the Company’s total issued shares.

The aforementioned transaction has resulted in a change in the Company’s major shareholding structure, based on the shareholders register as of 5 November 2025, as detailed below:
